I am directed to refer to your letter No. FCE(T)G/ADM/VOL.IV dated 11th December, 2024 on the above subject and convey the approval of the Honourable Minister of Education for a waiver to enable the Institution fill a total of One Hundred and Thirty-Five (135) positions as distributed in the attached list.

2. The approval is based on and limited to the 2024 Authorised Establishment positions on the Institution which covers the proposed recruitment.
3. Accordingly, I am to further advise you to comply as follows:
 - a. obtain financial clearance from the Budget Office of the Federation in line with the provisions of the extant Circular issued by the Office of the Secretary to the Government of the Federation before embarking on the recruitment exercise;
 - b. adhere to extant rules including the Federation Character principle, while filling the vacancies;
 - c. ensure that 5% of the recruitment is allocated to persons living with disabilities;
 - d. that on no account the approval should be varied or exceeded, in order not to unduly increase the personnel costs;
 - e. that the officials of the Ministry and the Office of the Head of the Civil Service of the Federation are required to be present during the exercise to ensure compliance with the approved waiver; and
 - f. that the list of successful candidates should be forwarded to the Ministry for approval, in the absence of a constituted Board, and the Office of the Head of the Civil Service of the Federation for record purposes.
